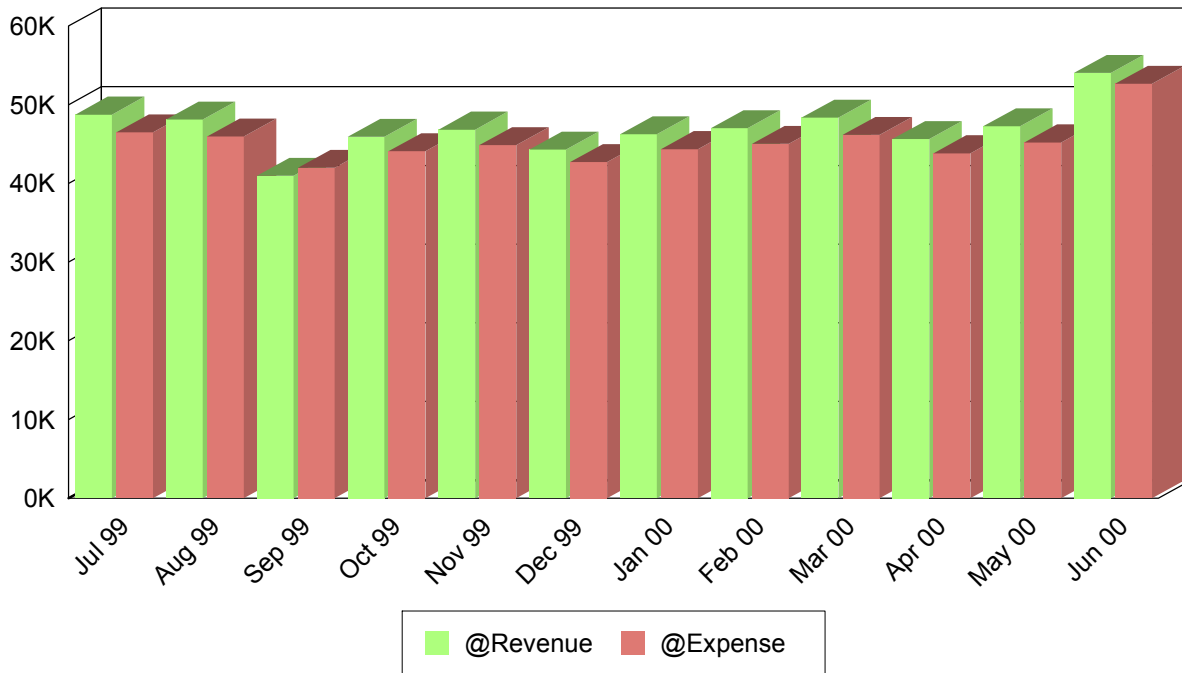

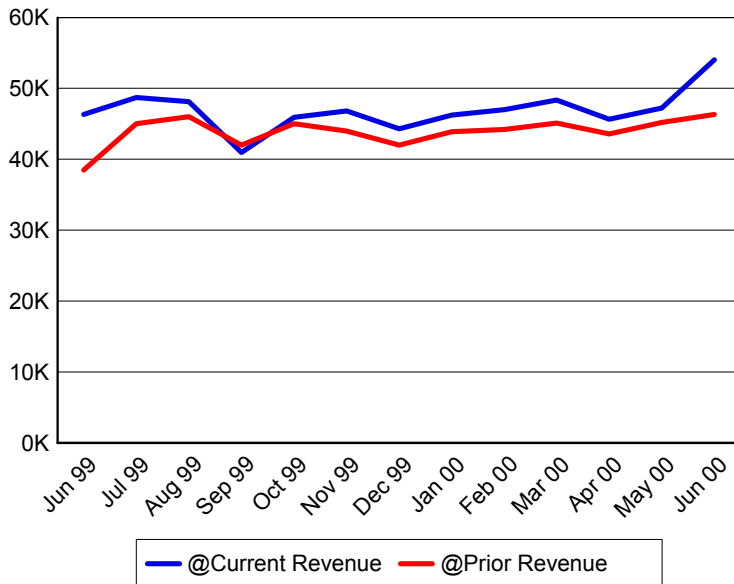

## One Year Revenue And Expense Comparison

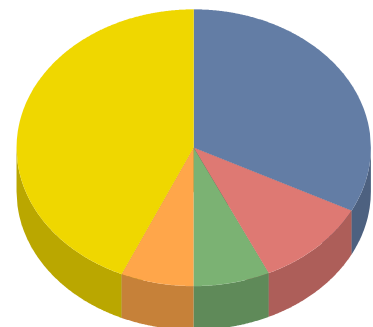


## Two Year Revenue Comparison

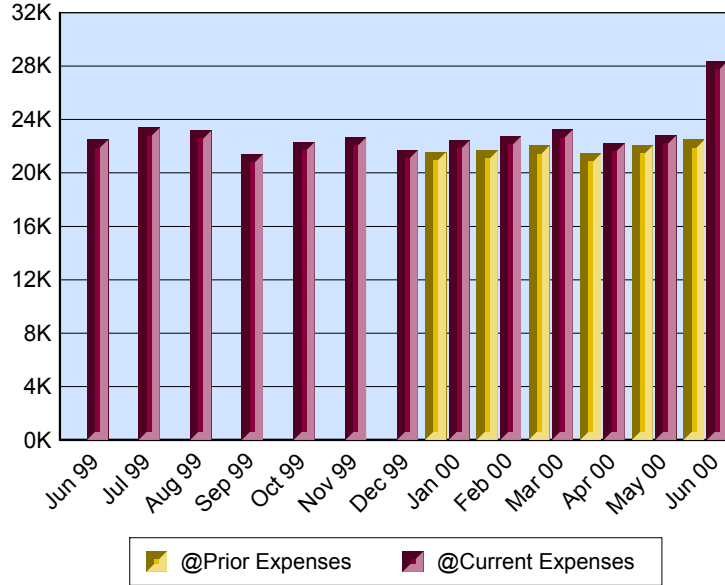

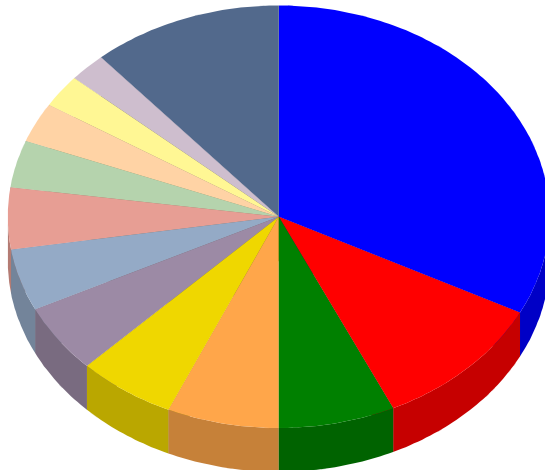
